Common Characteristics of Autism Spectrum Disorder

- ★ Inappropriate laughing or giggling
- ★ Social and communication delays
- ★ Resistant to change
- ★ Sensitive to changes in environment
- ★ No fear or real dangers
- ★ High pain tolerance
- ★ Sensitive to touch
- ★ Repetitive or unusual play
- ★ Limited eye contact
- ★ May prefer to be alone
- ★ Difficulty in expressing needs; may use gestures
- ★ Inappropriate attachment to objects
- ★ Insistence on sameness
- ★ Echoes words or phrases
- ★ Difficulty in interacting with others

How can Family Outreach help us?

Who is Family Outreach?

Family Outreach offers home based intervention services to children and adults with developmental disabilities. We have been in existence since 1977, providing, early intervention, support, family education and Autism services. These services are based on the family's priorities and each child's needs.

What is the Autism Insurance Program?

January 1, 2010 a law went into effect that requires health insurance companies to provide health insurance coverage for autism spectrum disorders for children birth-18 years of age. This coverage can include the Autism Services offered by Family Outreach.

Family Outreach offers accepted certified behavior therapies to address the educational and behavioral needs of your child.

How is Family Outreach involved?

Applied behavior analysis covered under this law must be provided by an individual who is licensed by the Behavior Analyst Certification Board or is certified by DPHHS as a family support specialist with an Autism Endorsement. Family Outreach has both individuals on staff.



How do I know if my Child is eligible?

WHAT DO YOU DO?

It will be necessary for you to contact your insurance company and ask if your child is found eligible for this service, what coverage they will provide.



Who's eligible?

Coverage under this section must be provided to a child who is diagnosed with one of the following disorders as defined by the most recent edition of the Diagnostic and Statistical Manual of Mental Disorders:

- (a) Autism Spectrum Disorder
- (b) Asperger's Disorder or
- (c) Pervasive Developmental Disorder (not otherwise specified)
